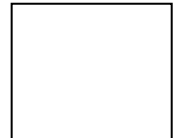

### CONDITIONS OF PLAY

The tournament will be played as follows:

- 72 holes of stroke over 4 days, the Wella Ladies Open will count as the first round of the Ladies Fiji Open.
- Categories-**Silver from handicaps 0 – 18; Bronze I - 19 -27 Bronze II : 28 – 36**
- The maximum handicap for this Open is 36.
- The Jade tees will be in use for all 4 days.
- The tournament will run in accordance with the rules of golf from The Royal & Ancient Golf Club of St Andrews and its decisions together with such local rule as approved by the Match Committee.
- A draw for play will be made and published.
- Players **MUST** report to the starter 15 minutes before the allocated time. Rule 6-3a provides “The Player **MUST** start at the time laid established by the Committee”. The penalty for breach of Rule 6-3a is disqualification. However it is a condition of this Event that, in the absence of circumstances which warrant waiving the penalty of disqualification as provided in Rule 33-7, if the player arrives at their starting point, ready to play, within five minutes of her starting time, the penalty for failure to start on time is two strokes at the first hole, instead of disqualification.
- All players will play on their current handicaps (with exception of those with handicaps of more than 36, they must play of a maximum of 36). **Proof of handicap must be produced upon request.**
- Water Hazards are marked with **yellow stakes** and Rule 26 shall apply.
- Lateral Water hazards are marked with **red stakes** and Rule 26 shall apply.
- Out of Bounds is marked by **white stakes with a black top.**
- **White line or Markers are GUR**
- Practice putting at the completion of a hole is not permitted. Penalty: 2 strokes for each breach. Maximum of 4 strokes per round.
- The player should ensure that her correct handicap is on her score card, date, check her score hole by hole and sign card together with her marker. Note once your card is handed in, Rule 6-6 applies.
- If there is a tie for the Overall Gross Winner, there will be a play off over holes 10, 11,& 18 thereafter if a tie remains then sudden death continuation from **hole number 18** will determine the winner. A tie for other prizes will be determined by a count back.
- A seeded draw will be made for the final day. The seeded draw will be based on the total gross of the prior rounds.
- Entry Fees will not be refunded under any circumstance.
- A player may win one daily prize and one major prize.
- Any decision of the Match Committee will be final in all matters relating to the Tournament. Any protest must be made verbally to the Match Committee by not later than 15 minutes after the completion of play on the day of the incident.
- The Match Committee reserves the right to vary any condition of the event.
- Use of GPS/DME: Recognized individual GPS or Distance Measuring Equipment (DEM) may be used.
- **Mobile Phones:** The use of a mobile phone either a competitor or his caddie during the play of competition is prohibited. A player in breach will be disqualified.
- Pace of Play: Rule 6.7 will be strictly enforced. Each group must maintain its position on the course with respect to the group preceding it. Any group with a clear hole in front of it will be considered out of position and if the pace of individuals in such group contributes to such delays, penalties may be issued without warning.
